1. I am a Regular, Life, President’s Club, Leaders Forum, or Sustaining member of the American Association for Justice (AAJ) in good standing. My AAJ Membership Number is _____ and I am a member in good standing of the bar(s) _____.
2. Neither I, nor anyone from my firm or anyone affiliated with my firm, defends or otherwise represents (including all forms of transactional work) any pharmaceutical or medical device manufacturers or any organization or group that represents the interest of pharmaceutical or medical device manufacturers or other similar companies. Neither I, nor anyone of my firm or anyone affiliated with my firm, engages in pharmaceutical, products liability, or personal injury defense.
3. Neither my practice nor my firm’s practice, in whole or meaningful part, has a significant relationship with interests adverse to, on inconsistent to, those of AAJ or the IVC Filters Litigation Group.
4. I desire to work in concert with other member attorneys representing plaintiffs in similar IVC Filters cases in cooperative effort to assist in achieving our common interests to prepare and fairly resolve individual cases properly.
5. I will not disclose any portion of, or any copies of, any information obtained from this Group to any company involved with IVC Filters or affiliate entity, their agents, employees, independent contractors, or to any person, firm or entity where the materials may be seen, copied, accessed, or otherwise reached by any IVC Filters related entity or person or affiliated entities.
6. I will not make recordings of any IVC Filters Litigation Group meetings or proceedings or any portion thereof without the written permission of the Chair or Cochairs.
7. I will fully and candidly share relevant information, documents, and other materials with other members of the IVC Filters Litigation Group.
8. I will not disclose information of a strategic nature to non-members if such disclosure would compromise the interests of members and their clients who are victims of IVC Filters.
9. I will not share, show, reveal, or disclose any information, documents, index, or materials obtained from the IVC Filters Litigation Group, its members, or the AAJ Exchange, nor will I distribute the information unless ordered to do so by a court of competent jurisdiction.
10. I will notify the Chair or Cochairs of the IVC Filters Litigation Group if any request is made to obtain the Index or any materials obtained from or through IVC Filters Litigation Group, and I will resist such attempts.
11. I understand that there will be a dues obligation to the Litigation Group, initially \$300 for the first member of a firm, and \$100 for each additional attorney from the same firm (with no firm paying more than \$400), but subject to reasonably necessary increases from time to time.

I understand that my initial and continued membership in this Litigation Group is contingent upon the payment of dues, membership in AAJ, membership in good standing of the Bar, and my ongoing commitment to the principles and representations made above on which I fully appreciate that my colleagues are strictly relying.

Membership dues paid to the American Association for Justice (AAJ) are not tax deductible as charitable contributions for income tax purposes. However, dues may be tax deductible as ordinary and necessary business dues and expenses subject to restrictions imposed as a result of AAJ's lobbying activities. AAJ estimates that the portion of dues and other similar amounts that it expects to receive that are allocable to AAJ's lobbying expenditures is 34%.
